

# Hollande and the Globalism

Several people are glad for the victory of Hollande in France. But what do we do with Hollande? What can we do, we, the citizens of Italy, or France, or Spain, or Greece, and so on...? Nothing for sure, nothing; nothing because Hollande will never skim the real problem: European Union. Has he promised to abandon the euro, perhaps? Did he say a word about the mammoth building that is gradually killing our Nations? No, Hollande is like all other politicians that are devastating Europe: he will make minimal changes, just enough to make people believe that there is still a political debate, a Right and a Left. At the same time, the insiders will keep working hard to destroy any resemblance of democracy, in order to achieve global governance, the implementation of globalization. The European Union was created with this purpose, it is the first important and even decisive step towards globalization. If we see so many ruins around us, it is because globalization can be achieved only by fragmenting what was once united. The EU is completing its task wonderfully well: to destroy the Nations, to make all States equal by canceling their sovereignty, in order to annihilate them. To take money away from the States is as to take it away from individuals: they cannot survive. The many suicides of these days, in Greece as in Italy, are an avant-guard, and at the same time they represent the future of the States, with tragic accuracy. Every day the globalist center perched in Europe is shooting its bullets - Equitalia style - using the European Council and the European Commission: they shoot against the economies. No illusions: if they are giving some money to the States it is only to prevent them from deciding to try to escape the hold out of despair, and to cut the strings that tie them up taking away any possibility of action.

In Italy we talk very little (or not at all) about the globalist "ideals" of the Anglo-Saxon world, supported by Europe. The term "ideal" must be considered for its real meaning: it is the aspiration, the desire, the goal of all those who deal with economy, finance, stock markets and banks. The reason is obvious: to do any type of operation, first of all one must find a lowest common denominator. In the case of "men" and "people", this lowest common denominator can be gradually reached only in one way: eliminating boundaries, fences, borders, inequalities, differences, in order to obtain and to deal with a huge mass of people that are *all equal*. These individuals will be only "consumers", people who buy and sell, the world will be one single market. And of course it will be guided by economists and bankers – as already happens in the European Union. They will be "guiding" us by using absolute power and dictatorship, the only way that bankers know; but they will continue to call it "democracy". The experiment has succeeded very well in Italy. Politicians still cheerfully carry the name of "politicians", despite having been completely deprived of any power by the President of what still pretends to be a "republic". The Italian President does not let them govern, and gave the name of "technicians" to those who *really* govern. This is particularly grotesque in the case of Mario Monti, whose past career is the most "political" one we ever saw: for two times he was appointed European Commissioner.

What project can be more foolish and doomed to failure than globalization? It does not take much to understand it; it is sufficient that someone shakes off lethargy, and rebels against suicide.
